TECHNICAL SPECIFICATIONS:

1. Section 00 11 16 – INVITATION TO BID

This project is funded with grant and loan funding from the MDEQ State Revolving Fund Loan Program and the American Rescue Plan Act (ARPA) program administered by the MDNRC. Award of the project will be contingent upon available funding and award concurrence from the MDNRC and MDEQ. American Iron & Steel (AIS) and Buy America, Build America Act (BABAA) provisions apply.

ARTICLE 30 – AMERICAN IRON AND STEEL (AIS) REQUIREMENTS

30.01 BIDDER'S attention is directed to this Article of the Instructions to Bidders for the American Iron and Steel Requirements for this project. All of the iron and steel products used in the project must be produced in the United States. The term "iron and steel products" means the following products made primarily of iron or steel: lined or unlined pipes and fittings, manhole covers and other municipal castings, hydrants, tanks, flanges, pipe clamps and restraints, valves, structural steel, reinforced precast concrete, rebar, and construction materials. The iron and steel products permanently incorporated in the project must comply with the American Iron and Steel requirements of Section 436 of the Consolidated Appropriations Act



of 2014 (P.L. 113-76) and as further interpreted by applicable EPA guidance (see http://water.epa.gov/grants funding/aisrequirement.cfm).

CLARIFICATIONS/INFORMATION:

1. MDEQ has stated that the old sludge storage pond south of the project site can be utilized for the disposal of construction dewatering effluent under the following condition: the pond must first be re-contoured to eliminate the risk of surface overflow to the Clark Fork or adjacent delineated wetlands. Presuming there is no discharge to State waters, an authorization under General Permit MTG-070000 for Construction Dewatering is not required. Please see Exhibit A for a plan sheet showing the location and size of the existing sludge storage pond.


